



## I Have Been or Know of a Client Who has Been Sexually Abused by a Homeopath. What do I do?

### WHAT IS SEXUAL ABUSE?

#### Sexual abuse is defined as:

It is important to note that sexual abuse is defined differently in the RHPA than the criminal code of Canada.

Sexual abuse of a patient by a member (as defined within the Regulated Health Professions Act, Schedule 2, 1 (3)) means:

- sexual intercourse or other forms of physical sexual relations between the member and the patient,
- touching of a sexual nature, of the patient by a member, or
- behaviour or remarks of a sexual nature by the member towards the patient.

Exception “sexual nature” does not include touching, behaviour or remarks of a clinical nature appropriate to the service provided.

The following information describes the College’s role and responsibilities related to the investigation of complaints about the sexual abuse of clients where the client has agreed to their name being included in the complaint.

It is extremely difficult for the College to investigate complaints regarding the sexual abuse if the individual (s) is not willing to share their story with the College in a fair amount of detail. The College is extremely sensitive to the needs of the individual during this stressful time and will make every effort to ensure that they are supported throughout the process and that the investigation is completed in a timely manner.

### What happens after I file a complaint?

Once the College receives your complaint, the homeopath will be advised of the complaint and provided the opportunity to respond. You will receive a copy of the response that is submitted to the College.

The information received from both you and the homeopath is then sent to the Inquiries, Complaints and Reports Committee (ICRC). A group of this Committee (a panel of – including at least three individuals – at least one person who is a member of the public appointed to the College by the Lieutenant Governor in Council of the Ontario Government and no more than two homeopaths) reviews the written information and decides if they need additional information before making their decision. To do this, they may ask a staff member to obtain the information about the nature of the complaint, ask an expert to comment on the case or ask that an investigator meet with different individuals who could help them understand what happened. If the investigator meets with the homeopath, they will likely also meet with you.

The panel reviewing the case tries to make their decision within 150 days. If they are unable to meet this deadline, you will be notified by mail about the delay. You are also welcome to contact the College at any time during the process if you have any questions or concerns.

### What are the possible decisions?

The College has adopted a **zero tolerance** policy with regards to sexual intercourse or other forms of physical sexual relations between the homeopath and the client and/or touching, of a sexual nature, of the patient by the homeopath. If the Committee has reasonable grounds to believe that sexual abuse occurred, the matter will automatically be referred to the Discipline Committee for a hearing. ... [Page 2](#)



## I Have Been or Know of a Client Who has Been Sexually Abused by a Homeopath. What do I do?

If the matter is referred to the Discipline Committee for a hearing and the homeopath is found guilty of professional misconduct (sexually abusing a client), the following outcomes or combination of outcomes are possible.

Mandatory revocation of their Certificate of Registration for a minimum of five years and a reprimand if the sexual abuse consisted of, or included, any of the following:

- sexual intercourse between the patient and the homeopath;
- genital to genital, genital to anal, oral to genital, or oral to anal contact;
- masturbation of the homeopath by, or in the presence of the patient;
- masturbation of the patient by the homeopath;
- encouragement of the patient by the member to masturbate in the presence of the homeopath;
- touching by the homeopath in a sexual nature of the patient's genitals, anus, breasts or buttocks.

And any combination of the following:

- suspension of the homeopath's certificate of registration for a specified period of time;
- terms, conditions and limitations being placed on the homeopath's certificate of registration for a specified or indefinite period of time;
- requiring the homeopath pay a fine of not more than \$35,000 to the Minister of Finance;
- reimbursing the College for funding provided for that patient;
- requiring the homeopath to post security acceptable to the College to guarantee the payment of any amounts the patient may be required to reimburse for the funding.

In some cases, alternative decisions may be explored by the panel and based on the information made available to them and where reasonable grounds and adequate information to support the referral to Discipline is not available, the Panel may:

- dismiss the case;
- caution the homeopath (provide guidance) in person or in a written letter;
- ask the homeopath to participate in an undertaking (contract) with the College where the homeopath is required to take certain action to address the concerns of the panel;
- refer the case to the Quality Assurance Committee if they feel that another homeopath should assess their practice; or
- refer the case to the Fitness to Practise Committee if they feel that the homeopath is mentally or physically unable to practice or if they believe that there are more concerns about the homeopath's practice outside of the complaint.

### What happens in the decision-making process?

During the ICRC process the panel of the ICRC does not access the credibility of the parties or decides if someone is guilty or innocent but does assess if the homeopath's practice has met the standards of the profession. At the end of the process, you will receive a written decision. If the ICRC decides to refer the case to the Discipline Committee you will receive written notification of this referral.

If you believe that the panel did not gather enough information before they made their decision or that their decision is unreasonable, you can appeal the decision.

The contact information of the Health Professions Appeal and Review Board (appeal board) will be included with the written decision. Please note that referrals to the Discipline Committee cannot be appealed through the appeals board but can be challenged in court.



## **I Have Been or Know of a Client Who has Been Sexually Abused by a Homeopath. What do I do?**

### **Access to Therapy and Counselling Funds**

A patient will be eligible to access funding for therapy or counseling from the Sexual Abuse Fund if it is alleged, in a complaint or report, that the patient was sexually abused by a homeopath while the person was a patient of the member.

Monies from the Fund can be used only to pay for therapy or counseling and must be paid directly to the counselor chosen by the client to provide the counseling. The maximum amount of funding is the equivalent of the amount the Ontario Health Insurance Plan (OHIP) would pay for 200 half-hour sessions of individual out-patient psychotherapy with a psychiatrist.

Individuals who believe that they are eligible for funding may contact the College for more information.

Funding can be provided for five years from the day the person became eligible. The amount provided to a client is supposed to be reduced by any amount that OHIP or a private insurer is required to pay for therapy or counseling during the period of eligibility for funding.
